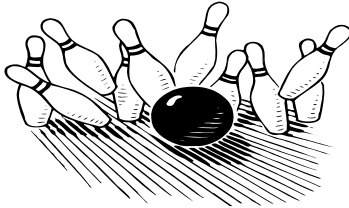

BUMPER TOURNAMENT RULES

1. This tournament is open to bowlers in the bumper leagues of the Joliet Area USBC Association who are age 8 or less as of August 1, 2021.
2. All Youth Bowlers must check in at the Tournament Office one-half (1/2) hour before their scheduled time to bowl.
3. Phone reservations will be taken for the tournament at (815) 955-4005. CLEARLY leave your first and last name, your call back number, as well as the date and time you want to bowl. Then mail in the entry along with fee to: Scott Ullian, 2741 Molly Court, New Lenox, IL 60451 by December 8, 2021. Reservations can also be made by emailing Scott at jausbcyouth@gmail.com. Confirmations will be sent to bowler's email address listed on entry. Late reservations will not be accepted. All late entries are considered walk-in entries and must be brought to the tournament office before the squad starts. Lane availability will be determined at that time.
Any entry sent to the Tournament Director that does not have a reservation will be considered to be a walk-in entry subject to the late fee of \$5.00 per bowler and lane availability for the squad desired.
4. Walk-in entries will be accepted until 30 minutes prior to the start of practice subject to lane availability. Entry blanks must be completed. A late/walk in fee of **\$5.00 per bowler** will be added to the entry fee. All walk-in entries subject to average verification.
5. No Youth Bowler will be allowed to practice on any lanes at the host bowling center before or during the Tournament. Practice by any Youth Bowler will result in immediate disqualification.
6. Foul lights will be in operation. Lanes will be assigned by the Tournament Director.
7. No eating, drinking, or smoking will be permitted by Youth Bowlers while participating in the Tournament.
8. Only the Youth Bowler is allowed on the approach to the lanes. Parents may not help the bowler.
9. ONLY Bowlers, official scorekeepers, & authorized tournament personnel are allowed in the bowling area.
10. **DRESS CODE:** The Youth Bowler's dress and grooming must not compromise reasonable standards of health, safety and decency. No headwear (Caps, Hats, Bandanas, et al.) or shirts with indecent words or logos (i.e., tobacco, alcohol, sex, or profanity) will be allowed. The only shirts allowed are the USBC shirt, a collared shirt, a bowling league shirt or a mock turtleneck shirt. No sweatpants. No spandex. Pants/slacks must be worn on the natural waistline and cannot contain rips or holes.
11. Any Bowler arriving late - follow Rule #322a of the USBC 2021-2022 Rule Book.
12. Machines will be turned on for ten (10) minutes of practice prior to the start of the tournament.
13. Any ball that does not make it down the lane will count as zero (0).
14. Machine Breakdown - see Rule #321 of the USBC 2021-2022 Rule Book.
15. **TOURNAMENT AVERAGE REQUIREMENTS: Use current year's average as of 11/27/21 with a minimum of six (6) games.**
An individual average sheet must be attached to the entry form to verify bowler's average.
16. All averages submitted on the entry forms are final. Falsification of averages or age will result in disqualification.
17. Individual Average sheets, if applicable, and Entry Fees must accompany all Entry Blanks. Make check payable to JAUSBCA. JAUSBCA is not responsible for late or lost mail. Entries received/postmarked after 12/8/21 are late and the \$5.00 late fee will be assessed. No exceptions.
18. Handicap is based on 90% of the difference between 150 and bowler's average.
19. Awards fee will be returned 100 percent.
20. Trophies will be awarded to all places.
21. **NO REFUNDS.**
22. All Scores posted at lanes will be **UNOFFICIAL** until final standings are announced.
